
## May 14<sup>th</sup> Meeting Minutes

I hope that everyone can attend these and the rest of the events planned through the year as it is one way we stand out over the other clubs in the area.



can get in and deliver more gravel to areas we are trying to improve and maintain. Dave was asked about using the excavator to help move the wood since it has a clam bucket on it. He will advise what he feels can be done and possibly report by next meeting.

The issue of painting the container came up due to Scout Camping season coming up in a couple months. The container is easily seen from the lodge and the better we make it look, the better the Scouts will appreciate it. Roof work needs to be completed so the tarps can come off and requests for paint sprayer equipment was made to make this short work. There are generators and air compressors available to handle the sprayers if any are available.

Jim Reynolds has graciously offered 3 gal of mobile roof coating and has offered to buy the necessary wood to finish the car track stand. It still needs some floor pieces, steps, back safety rails and plywood for the elevated part to use as a set up table or work table as needed. Bryan and Jay will estimate what is needed and contact Jim. Thank you Jim for your offer! (correction, this is (3) 5 gallon pails).

#### **NEW BUSINESS**

Mark reported that the recent work party went really well, 14 members showed up to lend a hand. Lots of projects were tackled. Awning covers were installed, flight table was built, debris moved out of drive on north end of barn, car track railing installed, container was pressure washed, Dirt moved and grass killer spread. Chet went out Monday and applied a coat of Thompson's Water Seal on the new flight table.

Mark asked for a motion to build 2 more flight tables. Motion made, seconded and passed. Chet will purchase wood and kit up another 2 tables in the near future.

Chet mentioned that he talked to the President of the Arlington Eagles and they have to pay \$50 per cutting since there are no volunteers within the club. If that is equivalent to our 25 week cut schedule that would be \$1250 per year. If we would ever have to do that, membership dues would definitely go up in all categories. Mark mentioned that the latest Model Aviation magazine had a really good article about all members being ambassadors for the Club. ## Work Party—May 11th













#### "Distraction Infraction"

Most of us have our own set of Rules to Live By, which have been born of reasoned logic, and which are often burned into our consciousness through the School of Hard Knocks (i.e., "lessons learned the hard way"). When we follow these rules dutifully and religiously, the benefits of adherence can be realized. When we deviate, we run the risk of a bitter reminder of the reason we established the rule in the first place. I had yet another wake-up call this past weekend on the importance of staying focused when preparing to fly an R/C airplane.

We were all flying our large-scale gliders at the Yakima Aerotow event out in the arid desert prairie east of Union Gap, WA. I decided to assemble my quarter-scale Schleicher Ka8b for the day's flying, so I placed all the components—wings, fuselage, horizontal stabilizer, canopy, on-board battery, fullbody pilot-- out on the ground and commenced putting everything together in the proper order. At that point, an old flying buddy pulled in to the field all the way from Utah and came up to greet me. We struck up a long refamiliarization chat, as old friends do, but in my haste to stay on task, I continued to work on getting the Schleicher ready. That was my mistake.

The last time I flew the Schleicher was a few seasons ago, and it had exhibited an annoying rigging issue, with an inclination to drop a wing and stall out of a thermal turn. I had done some fixes before the trip, such as adding more washout on the offending wing panel, and I wanted to know if I had managed to remedy the condition, so I was keen to see how the Ka8 behaved. The take-off behind the tug went smoothly, and the airplane seemed to fly well on tow. But the minute I came off tow at release height, the glider immediately became a bit of a handful, with a disturbingly erratic flight path. I had a hard time finding a good trim for the elevator, and there was that annoying tip stall again! I flew right into a strong thermal (which is common at this flying site), and managed to gain back some lost altitude as I struggled to keep the Ka8 happy. It did a lot of pitching up and down, in an erratic fashion, and I resolved to add some nose weight when I got it back down on the ground, thinking that maybe the CG was too far aft. The tip stall in banked turns at slow speed continued to plague me.

Finally, I managed to get the Ka8 safely back

down on the runway. It was a bit of a wild ride, and I was glad I had a couple of back-up airplanes with me for the event. When I brought the glider back to my staging area and set it down on the ground, I immediately spotted the problem. The horizontal stabilizer was loose in the saddle. I had forgotten to torgue down the two hold-down bolts! In my distracted haste, I had temporarily installed the stab in order do a controls check, but the bolts were only engaged by a few threads, with a lot to go before being fully seated and torqued. During the entire flight, the stab was moving up and down on the threads. No wonder I couldn't find a good trim setting! It amazes me that the glider flew as well as it did!

One of my Rules to Live By is to not allow myself to conduct any conversations while assembling my models. I should have turned to my friend at some point and said, "Let's continue this after I get my glider ready". He certainly would

have understood, I'm sure! Why do we allow ourselves such lapses in discipline? And how fortunate do I feel that the outcome of my negligence was not much, much worse? I got away with it this time. Next time I may not be so lucky.

## **Builder's Contest Rules**

The following are the rules for the Builder's Contest:

The model shall have been completed and in an operable state in the present contest year. If you started the build some years ago and finished it in the present contest year that well be acceptable. i.e. contest year is from the last builders contest to the present years builder contest.

No model completed in a prior year may be entered.

The model shall not be built by a more experienced or professional builder for the contestant. Get all the help and advice you need from a consultant, but remember the consultant is just that a consultant not the builder.

An unfinished model may be entered in an unfinished state one time.

Judging will be done by members in attendance at the meeting. People's Choice format. We will have **Kit or Plan Built** and **ARF's** categories.

Contestants will be given a short time to describe their entry. Time will depend on the number of entries and time available for the contest.

Judges will be looking for the following and points given or reduced as seen fit by the individual Judge. Points must be within the parameters indicated on the Judge's work sheet.

Full points will not be awarded for an unfinished entry.

Points will be added for an operational model only if it is documented on the entry sheet that it has functioned for the purpose that was built for. i.e. Aircraft shall have made at least one flight and landed under control. A boat should have floated and be controlled on the water and return to its starting point. Same idea for other contraptions

Points will be awarded for construction workmanship, covering, and finish.

Points will be awarded for engine (motor) installation and control system.

Points will be awarded for proper control linkage installation - with an eye for reliable and safety.

For ARF's only positive changes and/or improvement made by the builder will be considered. These must be detailed on the entry form or a separate sheet attached to the entry form. We will not be judging \$50.00 ARF against a \$500.00 ARF, only what the builder did to embellish or improve the model.

Our June 11, 2019 club meeting will be the date for the Builder's Contest this year.

## **3<sup>rd</sup> Annual Glider Day at the Barnyard—Another winning year!**

Saturday, May 18<sup>th</sup>, was the day of our annual glider event at the Buzzards field. We had thirteen contestants sign up, and most of the gliders were Radians again—for good reason! The Radian is affordable, easy to set up, and thermals as well as anything in its class. The conditions were nearly perfect for thermaling. The week before the contest, a low-pressure trough lingered for days, but it moved on just in time to provide us with excellent thermal conditions on Saturday, with abundant sunshine and clear air, and lots of convective lift in the area. Everyone got lots of long flight times in the buoyant air.

Tasks were all LMR (limited motor run), with a 30-second power-up, and then the remainder of the task time was spent in glide mode, with thermal lift carrying the gliders to the task goal of 5, 7, or 10 minutes total duration. Pilots scored one point per minute of flight time, with a max at the end of the task and no penalty for running past the stop whistle. Landing points were available to those who were able to land within reach of the staked landing ribbons. We wanted to paint circles on the runway, but the spray bottles weren't cooperating so we improvised by using landing ribbons, which seemed to work well. On one task, we exacted a one-point-per-second penalty for flights that extended beyond the stop whistle. I was surprised at how many guys were able to land within seconds of the ten minute limit! The last task was and "AULD" (all-up-last-down) task, of 30 minutes duration with no limit on power-ups. About half of the contestants were able to stretch their batteries and work the available lift to meet the thirty minute challenge.

It's never too early to get started on an electric glider for the upcoming contest next year, at the same time (3<sup>rd</sup> weekend in May). See you there!



## 25600 Monroe Camp Road, Snohomish, WA

Camp Edward and the Hanner's Memorial Field are located north of Monroe, Washington in Snohomish County. The most common route is from Highway 2 in Monroe near Albertson's. Turn north onto Woods Creek Road. As you travel north on Woods Creek road, it will come to a Y intersection, stay to the right (Yeager Rd). If you go the left as shown by MapQuest, make sure you take the next right to stay on Woods Creek Road. Then stay to the left at the intersection where Yeager rejoins Woods Creek Road, be careful as oncoming traffic does not stop. Yeager will rejoin Woods Creek Road at a 4-way intersection. Stay straight-ish, not a hard right, be careful as oncoming traffic does not stop. In a few miles you will pass the entrance to Camp Pigott. Keep going. Turn right at the "T" intersection at Lake Roesiger Road. At the next "Y" intersection, stay right, staying on South Lake Roesinger Road. Turn right at Monroe Camp Road, (Lake Roesinger Store will be on the left). In about a mile, the road will fork again, stay straight. After a short distance you will see the Red Barn and our gate. Our parking is past the gate on the East side of the barn. It seems complicated, but once you come out, you'll see it is an easy drive... —>Alfy's Pizza (our monthly meeting place) is along RT2 in the Staples plaza near the new Harbor Freight store.

Then, a **Show & Tell** and **raffle** conclude the meeting, which ends at around 8:30 PM.


